**WHEREAS,** a previous resolution authorizing TE #18 and prior emergency appropriations submitted for Municipal Council approval totaled \$118,425,215.18; and

**WHEREAS,** N.J.S.A. 40A: 4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** emergency appropriation adopted in 2017 pursuant to N.J.S.A. 40A: 4-20 including this resolution total..... \$118,437,715.18

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. A temporary emergency appropriation be, and the same is hereby made, for the following classification.
