### **NEWARK, NEW JERSEY, THAT:**

- 1. Orlando Vick, Sr., of 729 South 20<sup>th</sup> Street, Newark, New Jersey 07106, is hereby appointed as a Constable, in accordance with his application to serve and deliver summonses and subpoenas to appear in Court for criminal and civil matters; also to provide security to Occupy the Blocks & the Mayor's Critical Response Unit when needed.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of the appointment or to the expiration of the Constable Bond, whichever occurs first.
