- 1. Shadid Jamal Webb, of 54 Vermont Avenue, Newark, New Jersey 07106, be and is hereby appointed as a Constable, in accordance with his application to serve warrants, evictions, subpoenas and security detail.
- Prior to entering upon the execution of his office, and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by resolution of the Newark Municipal Council.
- This appointment shall be for a period of three (3) years from the date of the appointment or to the expiration of the Constable Bond, whichever occurs first.

## **STATEMENT**
