WHEREAS, on March 30, 2017, the Department of Economic and Housing Development conducted a public auction for the sale of City owned properties as shown on the attached Exhibit A, pursuant to N.J.S.A. 40A:12-13(a); and

WHEREAS, this resolution seeks to accept or reject the bids received on March 30, 2017, pursuant to N.J.S.A 40A:12-13(a).

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The City of Newark hereby accepts the offers to purchase the properties shown on the attached Exhibit A for the total amount of \$2,005,500.00; the sale of which was authorized for an open public auction to be held on March 30, 2017 through Resolution 7R2-d(AS), adopted March 1, 2017, and duly published in the Star Ledger on March 16, 2017 and March 23, 2017, pursuant to N.J.S.A. 40A:12-13(a).
- 2. The Deputy Mayor/Director of the Department of Economic and Housing Development of the City of Newark is hereby authorized to effectuate the sale of the properties shown on the attached Exhibit A to the successful bidders through a Quitclaim Deed, subject to the Standard Conditions of Sale set forth in Exhibit B attached hereto and made a part hereof, as authorized by Resolution 7R2-d (AS) March 11, 2017.
- 3. The Quitclaim Deed and all documents pertaining to the sale of the properties shown on the attached Exhibit A, shall be approved as to form by the City of Newark Acting Corporation Counsel to be attested and acknowledged by the City Clerk.
