**WHEREAS**, Reverend Dr. D.J. Jenkins was a noted religious leader in the City of Newark for many years and a very active member of the religious community.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Municipal Council does hereby authorize the honorary and ceremonial renaming of the intersection of Springfield Avenue and 15<sup>th</sup> Street as Rev. Dr. D.J. Jenkins Plaza.
2. The official name of the said streets shall remain Springfield Avenue and 15th Street in its

entirety.
