**WHEREAS**, the Division of Traffic and Signals, Department of Engineering, City of Newark, advertised a second time for receipt of bids; bids were advertised on April 28, 2016, May 5, 2016 and May 12, 2016, for Contract No. 04-2014(R), Federal Project No. STP 7628(103) CON, Broad Street at South Street, Tichenor Street and Lincoln Park Pedestrian Safety Project; and

**WHEREAS**, on June 2, 2016, the Division of Traffic and Signals received one (1) bid from Berto Construction Inc. Contract No. 04-2014(R), Federal Project No. STP 7628(103) CON, Broad Street at South Street, Tichenor Street and Lincoln Park Pedestrian Safety Project, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, based on a review of the bid, the Director of the Department of Engineering, desires to accept the bid proposal submitted by the lowest responsible bidder Berto Construction Inc., 625 Leesville Avenue, Rahway, New Jersey 07065 and execute Contract No. 04-2014(R), Federal Project No. STP 7628(103) CON, Broad Street at South Street, Tichenor Street and Lincoln Park Pedestrian Safety Project, for an amount not to exceed \$2,263,406.89 (Two Million Two-Hundred Sixty-Three Thousand Four Hundred and Six Dollars and Eighty-Nine Cents) for a period of 365 consecutive calendar days from the issuance of a formal Notice to Proceed by the Director of the Department of Engineering.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to accept the bid proposal submitted by the lowest responsible bidder, Berto Construction Inc., 625 Leesville Avenue, Rahway, New Jersey 07065 and execute Contract No. 04-2014(R), Federal Project No. STP 7628(103) CON, Broad Street at South Street, Tichenor Street and Lincoln Park Pedestrian Safety Project, for an amount not to exceed \$2,263,406.89 (Two Million Two-Hundred Sixty-Three Thousand Four Hundred and Six Dollars and Eighty-Nine Cents) for a period of 365 consecutive calendar days from the issuance of a formal Notice to Proceed by the Director of the Department of Engineering.
- 2. Attached hereto are Certifications of Funds issued by the Chief Financial Officer, City of Newark, which states that there are available sufficient legally appropriated funds in the amount of \$2,263,406.89 (Two Million Two-Hundred Sixty-Three Thousand Four Hundred and Six Dollars and Eighty-Nine Cents) for the purpose set forth hereinabove. Copies of the Certification of Funds issued shall be filed in the Office of the City Clerk by the Director of the

Department of Engineering together with this resolution.
