**WHEREAS**, on April 5, 2017, the Newark Municipal Council adopted Resolution 7R2-c, which introduced and approved the proposed budget of the Partnership West, Inc., Special Improvement District Management Corporation (West Ward Special Improvement District) for the Year 2017 (January 1, 2017 through December 31, 2017) ("FY 2017"), in the amount of \$500,000.00 (Five Hundred Thousand Dollars and Zero Cents), and scheduled a public hearing upon said budget for May 17, 2017, as required under N.J.S.A. 40:56-84 et seq.; and

**WHEREAS**, the proposed West Ward Special Improvement District budget for FY 2017 as well as the time and place for the May 17, 2017 hearing were publicly advertised in the Star Ledger on April 18, 2017, which date represents at least ten (10) days prior to the hearing date of May 17, 2017, as required by N.J.S.A. 40:56-84(d); and

**WHEREAS**, the hearing date of Wednesday, May 17 2017, represents no less than 28 days from April 5, 2017, the date of the approved budget, as required by N.J.S.A. 40:56-84(e); and

**WHEREAS**, the West Ward Special Improvement District budget for FY 2017 was also posted in a public place where public notices are customarily posted within the basement area of Newark City Hall, and a copy of said budget will be made available to those persons requesting same during the week prior to and the day of the public hearing.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The City Clerk is hereby authorized to read the budget, by title, of the Partnership West, Inc., Special Improvement District Management Corporation (West Ward Special Improvement District) for the year January 1, 2017 through December 31, 2017 (FY 2017).
2. All of the conditions outlined in paragraph (1) of N.J.S.A. 40:56-84(f) have been satisfied.
3. The amount anticipated to be raised by the special assessments to support the Budget of the District is estimated to be \$500,000.00 (Five Hundred Thousand Dollars and Zero Cents) and the Director of Finance shall pay over to the Partnership West, Inc., Special Improvement District Management Corporation (West Ward Special Improvement District) in installments of 25% of the total estimated assessments quarterly.
4. The City's Finance Director shall withhold from the quarterly payments to the Partnership West, Inc., Special Improvement District Management Corporation (West Ward Special Improvement District) an Administrative Fee of 1% of the amount of special assessments billed by the Tax Collector to support the Budget of the BLC.
5. The Partnership West, Inc., Special Improvement District Management Corporation's (West Ward Special Improvement District) Budget for FY 2017 in the amount of \$500,000.00 (Five Hundred Thousand Dollars and Zero Cents), is hereby adopted.
6. The Municipal Council hereby ratifies its authorization of this budget from January 1, 2017 through the date of adoption of this authorizing resolution.
7. A copy of this Resolution and the Partnership West, Inc., Special Improvement District Management Corporation's (West Ward Special Improvement District) budget for FY 2017 shall be placed on file by the Department of Economic and Housing Development with the Office of the City Clerk.
8. The City Clerk's Office shall forward certified copies of this resolution to the Business Administrator, the Director of Finance, Tax Collector and Tax Assessor.
9. This Resolution shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey.
