**WHEREAS**, pursuant to *N.J.S.A.* 40A:9-125, Oliver Richard Mayson, must give a bond within thirty (30) days of the initial adoption of the resolution of appointment in such form and amount as prescribed by the Governing Body and approved as to form and legality by the Acting Corporation Counsel and Municipal Council; and

WHEREAS, pursuant to N.J.S.A. 40A:9-121, a constable must qualify within thirty (30) days of

the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The term of the Constable appointment of Oliver Richard Mayson, of 195 1<sup>st</sup> Street, Unit 2N, Newark, New Jersey 07107, is for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
