**WHEREAS,** N.J.S.A. 54:5-19.1 authorizes electronic tax sales pursuant to rules and regulations to be promulgated by the Director of the Division of Local Government Services; and

**WHEREAS,** the Director of the Division of Local Government Services has promulgated rules and regulations for pilot programs; and

**WHEREAS,** the Director of the Division of Local Government Services has approved NJTaxLieninvestors.com and RealAuction.com to conduct pilot programs; and

**WHEREAS,** the City of Newark desires to submit an application for participation in the pilot

program for an Electronic Tax Sale; and

**WHEREAS**, an Electronic Tax Sale is innovative and provides a greater pool of potential lien buyers, thus creating the environment for a more complete tax sale process; and

**WHEREAS**, the Business Administrator and the Chief Financial Officer deem it necessary, and in the best interest of time, volume and expediency with the assistance of the Tax Collector, to conduct an Electronic Accelerated Tax Sale on or before December 31, 2017, with the approval of the Director of the Division of Local Government Services.

**NOW, THEREFORE, BE IT RESOLVED, BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Tax Collector is hereby authorized to complete an application (attached as Exhibit A) to participate in the Electronic Tax Sale Pilot Program and submit same to the Director of the Division of Local Government Services for his approval.
2. The Tax Collector shall file a copy of the resolution and approval from the Director of the Division of Local Government Services with the Office of the City Clerk.

### **STATEMENT**

This resolution authorizes the Tax Collector to complete and submit an application, on behalf of the City of Newark, to participate in the Electronic Tax Sale Pilot Program for an Electronic Standard and Accelerated Tax Sale.
