NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. John Martin Lema, of 247 Mt. Prospect Avenue, Newark, New Jersey 07104, is hereby appointed as a Constable, in accordance with his application to serve legal notices and executions.
- 2. Prior to carrying out the duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a term of three (3) years from the date of appointment or the expiration of the Constable bond, whichever occurs first.
