WHEREAS, the State of New Jersey Department of Transportation ("NJDOT") State Aid to Counties and Municipalities FY2018 Municipal Aid Program ("NJDOT Municipal Aid Program") provides grant funding for the improvement and construction of local, municipal, and county road and bridge projects; and

WHEREAS, on October 2, 2017, on behalf of the City of Newark, the Director of the Department of Engineering submitted an application to the NJDOT requesting grant funding in the amount of \$3,495,000.00 from the NJDOT Municipal Aid Program for Street Resurfacing - Various Streets - 2018 - Newark (17 locations, MA-18) within the City of Newark, identified as application MA-2018-VARIOUS STREETS-2018 (17 LOCATIONS) -00579 for City of Newark with no City funds required; and

WHEREAS, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a resolution from the Newark Municipal Council authorizing submission of the grant application; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering desires to accept the grant award and execute a grant agreement governing said award; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application MA-2018-VARIOUS STREETS-2018 (17 LOCATIONS)-00579 for City of Newark, the Director of the Department of Engineering shall submit a copy of the grant agreement to the City Clerk, Acting Corporation Counsel and the Business Administrator.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Municipal Council of the City of Newark formally approves the grant application for the above-stated project.
2. The Mayor and/or his designees, the Director of the Department of Engineering are hereby authorized to submit an electronic grant application, identified as MA-2018-VARIOUS STREETS-2018 (17 LOCATIONS)-00579 to the New Jersey Department of Transportation, on behalf of the City of Newark, requesting grant funding in the amount of \$3,495,000.00 from the NJDOT Municipal Aid Program for Street Resurfacing - Various Streets - 2018 - Newark (17 locations, MA-18), within the City of Newark with no City funds required (a copy of the application is attached hereto and made a part hereof).
3. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing resolution.
4. Upon notification of the receipt of a grant award in connection with this application, the grant is hereby accepted.
5. Upon notification of the receipt of a grant award in connection with this application, the Mayor and/or his designees, the Director of the Department of Engineering and the City Clerk, are hereby authorized to enter into and execute grant documents with the NJDOT to receive and expend the grant award for Street Resurfacing - Various Streets - 2018 - Newark (17 locations, MA-18) within the City of Newark.
6. Upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering shall submit a complete copy of the grant agreement and any associated documents to the City Clerk, Acting Corporation Counsel and the Business Administrator for review, approval, and signature.
7. No municipal funds are required for receipt or acceptance of this grant award.
8. The Director of the Department of Engineering shall file a fully-executed copy of the grant application, grant award letter, and the grant agreement in the Office of the City Clerk.
