**WHEREAS**, an emergency has arisen in Special Item of Appropriation in the amount of \$2,293,563.00, for the Homeless HRSA Program and no adequate provision has been made in the 2014 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS,** by award letter dated October 17, 2013, from the U.S. Department of Health and Human Services/Health Resources and Services Administration, the City of Newark was awarded the Homeless HRSA Grant in the amount of \$2,293,563.00 to provide medical care, social services, substance abuse and mental health counseling to the homeless population within the City of Newark (Citywide); and

**WHEREAS**, N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** the emergency appropriations adopted in 2014, pursuant to <u>N.J.S.A.</u> 40A: 4-20 including this resolution total.......\$5,293,473,00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be and the same is hereby made for the following classification.

## **STATEMENT**

This Legislation establishes the appropriation for the Homeless HRSA Program in the amount of \$2,293,563.00. The U.S. Department of Health and Human Services, ,Health Resources and Services Administration is awarding the funds. The project period is November 1, 2013 through October 31, 2014 (City Wide).
