**WHEREAS,** an emergency has arisen in Special Item of Appropriation in the amount of \$46,643.00 for 2017 Port Security Grant and no provision has been made in the 2018 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS,** a previous resolution authorizing TE #11 and prior emergency appropriations submitted for Municipal Council approval totaled \$71,944,561.15; and

**WHEREAS,** N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be, and the same is hereby made, for the following classification.

2017 Port Security Grant \$46,643.00

- 2. Said emergency appropriation shall be provided for in the 2018 budget.
- 3. A copy of this resolution shall be immediately filed with the Director of Local Government Services by the City Clerk of the City of Newark.

## **STATEMENT**

This legislation establishes the temporary emergency appropriation for a cash match in the amount of \$46,643.00 for the 2017 Port Security Grant, bringing the total program resources to \$186,571.00.
