WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-120, the City of Newark may appoint up to fifty (50) Constables; and

WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-121, the City of Newark may appoint a Constable for a term of three (3) years, unless the Municipal Council, by its resolution of appointment, fixes a one (1) year term; and

WHEREAS, the City of Newark wishes to appoint Jamar T. Piercy, to serve as a Constable for a term of three (3) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Jamar T. Piercy, 901-903 South 20th Street, Newark, New Jersey 07108, is hereby appointed as a Constable in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
- 2. Prior to carrying out duties of his office, and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of the appointment or the expiration of the Constable Bond, whichever occurs first.
