WHEREAS, pursuant to N.J.S.A. 40A:9-125, Rafael A. Brito, 10 Hill Street, Apt. #18L, Newark, New Jersey 07102, must give a Bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and

WHEREAS, pursuant to N.J.S.A. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The term of the Constable appointment of Rafael A. Brito, 10 Hill Street, Apt. #18L, Newark, New Jersey 07102, is for a period of three (3) years, from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
