NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Debbra L. Fletcher, 135 Sunset Avenue, Newark, New Jersey 07106, is hereby appointed as a Constable, in accordance with her application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
