WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-125, Leon Purdie, 87 Lenox Street, Newark, New Jersey 07106, must give a Bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and

WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The term of the Constable appointment of Leon Purdie, 87 Lenox Street, Newark, New Jersey 07106, is for a term of three (3) years from the date of the appointment or the expiration of the Constable Bond, whichever occurs first.
