NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Marques-Aquil D. Lewis, 33 Vaughn Drive, Newark, New Jersey 07103, is hereby appointed as a Constable, in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
- 2. Prior to carrying out duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Newark Municipal Council.
