WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-120, Jamar T. Piercy, 901-903 South 20th Street, Newark, New Jersey 07108, was appointed as a Constable, pursuant to Resolution 7R8-a adopted at the September 6, 2018 Regular Municipal Council Meeting; and

WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-125, Jamar T. Piercy, 901-903 South 20th Street, Newark, New Jersey 07108, must give a Bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and **WHEREAS**, pursuant to <u>N.J.S.A</u>. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:
