**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:9-120, Marques-Aquil D. Lewis, 33 Vaughn Drive, Newark, New Jersey 07103, was appointed as a Constable pursuant to Resolution 7R8-c adopted at the Regular Municipal Council Meeting on October 24, 2018; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:9-125, Marques-Aquil D. Lewis, 33 Vaughn Drive, Newark, New Jersey 07103, must give a Bond, in such form and amount, as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment and shall hold office for a term of three (3) years.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The term of the Constable appointment of Marques-Aquil D. Lewis, 33 Vaughn Drive, Newark, New Jersey 07103, is for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
- 2. The Constable Bond in the amount of One Thousand Dollars (\$1,000.00) issued to Marques-Aquil D. Lewis, 33 Vaughn Drive, Newark, New Jersey 07103, is approved as to form, amount and sufficiency.
