**WHEREAS**, the Newark Public Safety Director recommends that the gift from Google LLC be accepted, pursuant to N.J.S.A. 40A:5-29; and

**WHEREAS**, the gift shall not be put to any use which is inconsistent with the laws of New Jersey or the United States; and

**WHEREAS**, Google LLC fully understands and acknowledges that it is not entitled to receive any direct or indirect benefit from the City of Newark in exchange for its gift.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Mayor and/or his designees, the Business Administrator and/or the Public Safety Director, are hereby authorized to accept a gift from Google LLC, 1600 Amphitheatre Parkway, Mountain View, California 94043, in the amount of Ten Thousand Dollars and Zero (\$10,000.00) for the Public Safety Department's participation in a study conducted on virtual reality for law enforcement training.
2. The Municipal Council ratifies the acceptance of the gift from December 19, 2018 to the date of the adoption of this resolution.
3. No Municipal funds will be expended in the acceptance of this gift.
4. The original executed gift award letter from Google LLC shall be filed in the Office of the City Clerk by the Public Safety Director.
