WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$2,662,579.00 for HOME Investment Partnership Act and no adequate provision has been made in

the 2019 Temporary Budget for the aforesaid purpose and N.J.S.A. 40:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by notice of award letter dated October 3, 2018, from the United States Department of Housing and Urban Development (HUD), awarded the City of Newark the HOME Investment Partnership Program FY2018, in the amount of \$2,662,579.00; and

**WHEREAS**, N.J.S.A 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, the emergency appropriation adopted in 2019 pursuant to <u>N.J.S.A.</u> 40A:4-20 including this resolution total is \$ 72,148,974.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. An emergency appropriation be and the same is hereby made for the following classification:
