BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

SECTION 1. SECTION 2. The positions noted above (except where indicated) are to be considered in the managerial or exempt class of positions with no standard hours of work. The incumbent employed in such position shall be responsible for the completion of assigned duties and shall not be entitled to overtime compensation or to any accumulation of compensatory time. Where required for data processing purposes only, the above noted salary shall be calculated on a forty (40) hour work week except as otherwise noted.

SECTION 3. All prior ordinances or parts of prior ordinances which relate to the above positions, titles, hours of employment, number of positions, or annual minimum and annual maximum salary therefore, which are inconsistent herewith, are hereby repealed.

SECTION 4. This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

STATEMENT

This ordinance establishes salaries for positions in the Office of the Mayor; the Office of the City Clerk; the Office of the Business Administrator; the Department of Public Safety; the Department of Economic and Housing Development; the Department of Health & Community Wellness; the Department of Engineering; the Department of Finance; the Department of Public Works; the Department of Water / Sewer Utilities; the Department of Recreation; and, the Department of Law.
