made in the 2019 Temporary Budget for the aforesaid purpose, and <u>N.J.S.A.</u> 40A:4-20 provides for the creation of an emergency appropriation for the same; and

**WHEREAS**, by a Notice of Award dated February 4, 2019, from the State of New Jersey, Department of Health, Division of Family Health Services, the City of Newark has been award an additional \$59,000.00 for BFPC; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be and the same is hereby made for the following classification

ProgramAmountBFPC Program\$59,000.00

- 2. Said emergency appropriation shall be provided for in the 2019 budget.
- 3. A copy of this resolution shall be filed with the Director of Local Government Services by the City Clerk of the City of Newark.

#### **STATEMENT**

This legislation authorizes the temporary emergency appropriation for the Breastfeeding Peer Counseling Program in the amount of \$59,000.00. The State of New Jersey, Department of Health, Division of Family Health Services, has awarded the funds. The performance period for this funding is October 1, 2018 through September 30, 2019.
