WHEREAS, the City of Newark recognizes the significance and necessity for global interaction; and

WHEREAS, the City of Newark acknowledges the great benefits to all of its residents of cultural and economic exchanges with other municipalities and towns from around the world; and

WHEREAS, the City of Newark feels that it is befitting to establish a meaningful relationship with the Municipality of Guiglo, Ivory Coast (Republique de Cote D'Ivoire), West Africa; and

WHEREAS, the Governing Body of the City of Newark deems a Sister City relationship between these two (2) distinguished municipalities is in the best interest of the citizens of Newark and

the Municipality of Guiglo, Ivory Coast (Republique de Cote D'Ivoire), West Africa for many reasons including:

- The cultural and heritage identification between African-Americans in Newark with residents of Guiglo, Ivory Coast (Republique De Cote D'Ivoire), West Africa
- The possibility of commerce between businesses in the two (2) cities
- The potential for export/import of manufactured goods between the two (2) cities
- The opportunity for cultural and student exchange programs with high school and college students.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. It does hereby agree to establish a Sister City relationship with the Municipality of Guiglo, Ivory Coast (Republique De Cote D'Ivoire), West Africa.
