WHEREAS, the City of Newark desires to further the public interest by obtaining funding from the NJDOT Municipal Aid Program for Street Resurfacing - Various Streets - 2020 - Newark (25 locations, MA-20) within the City of Newark; and

WHEREAS, on July 11, 2019, on behalf of the City of Newark, the Director of the Department of Engineering submitted an application to NJDOT requesting grant funding in the amount of \$3,573,102.00 from the NJDOT Municipal Aid Program for Street Resurfacing - Various Streets - 2020 - Newark (25 locations, MA-25) within the City of Newark, identified as application MA-2020-VARIOUS STREETS-2020 (25 LOCATIONS) - 00688 for City of Newark with no City funds required; and

WHEREAS, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a resolution from the Newark Municipal Council authorizing submission of the grant application; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering desires to accept the grant award and execute a grant agreement governing said award; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application MA-2020-VARIOUS STREETS-2020 (25 LOCATIONS) -00688 for City of Newark, the Director of the Department of Engineering shall submit a copy of the grant agreement to the City Clerk, Corporation Counsel and the Business Administrator.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Municipal Council of the City of Newark formally approves the grant application for the above-stated project.

- 2. The Mayor and/or his designees, the Director of the Department of Engineering, are authorized to submit an electronic grant application identified as MA-2020-VARIOUS STREETS-2020 (25 LOCATIONS)-00688 for the City of Newark to the New Jersey Department of Transportation on behalf of the City of Newark requesting grant funding in the amount of \$3,573,102.00 from the NJDOT Municipal Aid Program for Street Resurfacing Various Streets 2020 Newark (25 locations, MA-20) within the City of Newark with no City funds required (a copy of the application is attached hereto and made a part hereof).
- 3. The Municipal Council ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing resolution.
- 4. Upon notification of the receipt of a grant award in connection with this application, the grant is accepted.
- 5. Upon notification of the receipt of a grant award in connection with this application, the Mayor and/or his designees, the Director of the Department of Engineering and the City Clerk, are authorized to enter into and execute grant documents with the NJDOT to receive and expend the grant funds for Street Resurfacing Various Streets 2020 Newark (25 locations, MA-20) agreement on behalf of the City of Newark, which shall constitute acceptance of the terms and conditions of the grant agreement.
- 6. Upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering shall submit a complete copy of the grant agreement and any associated documents to the Corporation Counsel and the Business Administrator for review, approval, and signature.
- 7. No municipal funds are required for receipt or acceptance of this grant award.
- 8. The Director of the Department of Engineering shall file a fully-executed copy of the grant application, grant award letter, and grant agreement in the Office of the City Clerk.
