WHEREAS, Mother Brown was a faithful member of the Greater Mt. Moriah Baptist Church where she held leadership position including being an Ordained Church Mother on the Mother's Board and President of the Missionary Circle; and

WHEREAS, Mother Brown counseled numerous families, at-risk youths and individuals in the

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Municipal Council does hereby authorize the honorary and ceremonial renaming of the intersection of Wright Street and Clinton Avenue "Mother Willie Brown Way".
- 2. The official name of the said streets shall remain Wright Street and Clinton Avenue in their entirety.
