**WHEREAS**, pursuant to <u>N.J.S.A</u>. 40A:9-120, Anthony Lamont Holden, 138 Huntington Terrace, Newark, New Jersey 07112, was appointed as a Constable pursuant to Resolution 7R8-a adopted at the September 5, 2019 Regular Municipal Council Meeting; and

**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40A:9-125, Anthony Lamont Holden, of 138 Huntington Terrace, Newark, New Jersey 07112, must give a bond in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and

**WHEREAS,** pursuant to <u>N.J.S.A</u>. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years; and

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The term of the Constable appointment of Anthony Lamont Holden, 138 Huntington Terrace, Newark, New Jersey 07112, is amended from September 5, 2019 to a period of three (3) years from the date of the Constable Bond to its expiration.
- 2. The Constable Bond in the amount of \$1,000.00 issued to Anthony Lamont Holden, 138 Huntington Terrace, Newark, New Jersey 07112, is approved as to form, amount, and sufficiency.
