WHEREAS, Michael Carson, a devoted and lifelong Newark resident, became involved at an early age as an active member of Newark and Essex County politics. He would later be appointed and served for many years as a Commissioner for the Essex County Board of Elections; and

WHEREAS, Michael Carson was a faithful member of Newark's Republican Party and rose through the ranks to assume party leadership as the long-serving Chairman of the North Ward Republican Committee.
