**WHEREAS**, the City of Newark advertised Contract 14-WS2017 Phase-1(C) Sewer Cleaning and Rehabilitation, located at various locations in the City of Newark, on April 22, 2019; and

**WHEREAS**, the Department of Water and Sewer Utilities ("Department") distributed eleven (11) bid packages to prospective vendors following the date of bid advertisement; and

**WHEREAS**, on May 22, 2019, the Department received three (3) bids for said project in accordance with the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, North American Pipeline Services, LLC, 210 Bennett Road, Freehold, New Jersey 07728 submitted the lowest responsive and responsible bid, according to the specifications and in the total amount of \$5,652,320.00 for the base bid, and in the total amount of \$43,650.00 for the supplemental bid, with a combined base bid and supplemental bid total amount of \$5,695,970.00; and

**WHEREAS**, due to a limitation in mobilization costs under bid item 1 not to exceed \$150,000.00 as per NJDEP regulations, N.J.A.C. 7:14-2.9, and pursuant to Article 8.2 of the Instruction to Bidders, which allows for discrepancies in sums to be adjusted to the correct sum (here corrected as per NJDEP regulations) North American Pipeline Services LLC's base bid price was adjusted to \$5,632,320; and

**WHEREAS**, the City of Newark wishes to accept the lowest responsible bid submitted by North American Pipeline Services, LLC on May 22, 2019, and execute Contract 14-WS2017 Phase-1(C) Sewer Cleaning and Rehabilitation, with North American Pipeline Services LLC, 210 Bennett Road, Freehold, New Jersey 07728, for the total amount of \$5,632,320.00 for the base bid, and in the total amount of \$43,650.00 for the supplemental bid, with a combined base bid and supplemental bid total amount not to exceed \$5,675,970.00; and

**WHEREAS**, the Municipal Council adopted the Contractor Pay-to-Play Reform Ordinance, R.O. 2:4-22C, which forbids the award of a contract of a Business Entity, as defined therein, which has made or solicited political contributions to Newark Municipal Candidates, office holders having ultimate responsibility for the award of a contract; candidate committees of the aforementioned candidates, and political or political party committees of the City of Newark or County of Essex; and continuing political committees or political action committees regularly engaged in the support of the City of Newark Municipal or County of Essex elections; and certain other political party or candidate committees, in excess of certain thresholds; and

**WHEREAS**, this contract is for an amount over \$17,500.00 and is being awarded as a Fair and Open contract pursuant to N.J.S.A. 19:44A-20.5.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Municipal Council hereby authorizes the Mayor and/or his designee, the Acting Director of the Department of Water and Sewer Utilities, to accept the lowest responsible bid submitted by North American Pipeline Services LLC, on May 22, 2019, and execute Contract 14-WS2017 Phase-1(C) Sewer Cleaning and Rehabilitation, with North American Pipeline Services LLC, 210 Bennett Road, Freehold, New Jersey 07728, for the combined base bid and supplemental bid total amount not to exceed \$5,675,970.00.
2. Attached hereto is a Certification of Funds from the Chief Financial Officer, which states that

funds in the amount of \$5,675,970.00, are available in the Water and Sewer Capital Budget under Business Unit NW044, Department ID 11G, Division/Project 11SA0, Account # 94710, and which shall be filed along with the original resolution in the Office of the City Clerk.

3. There shall be no amendment or change to the contract without approval by the Newark Municipal Council.
3. There shall be no advance payment on this contract in accordance with N.J.S.A. 40A:5-16.
3. A fully executed copy of the contract shall be filed in the Office of the City Clerk, by the Department of Water and Sewer Utilities.
3. This contract was solicited and awarded pursuant to the provisions of the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq., and is in compliance with the City's Contractor Pay-to-Play Reform Ordinance, R.O. 2:4-22C.
3. If required by the State Law, the City Clerk shall provide the appropriate notice of the award of this contract to the State Comptroller no later than 20 business days following such award, in accordance with N.J.S.A. 52:15C-10 and the Notice of the Office of the State Comptroller dated May 7, 2008.
