WHEREAS, based on a review of the bids, the Director of the Department of Engineering, desires to award Contract No. 2019-02, Installation of Pavement Markings on Various Streets in the City of Newark, to the lowest bidder, Statewide Striping Corporation, 499 Pomeroy Road, Parsippany, New Jersey 07054, for the total bid amount of \$239,250.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

The Mayor and/or his designees, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark, to accept the bid proposal submitted by the lowest responsible bidder, Statewide Striping Corporation, 499 Pomeroy Road., Parsippany, New Jersey 07054, and execute Contract No. 2019-02, Installation of Pavement Markings on Various Streets in the City of Newark, for the total bid amount of \$239,250.00.
