WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of Four Hundred Thousand Dollars and Zero Cents (\$400,000.00) for the New Jersey Victim Assistance Grant (Central Ward Project), and no adequate provision has been made in the 2020 Temporary Budget for the aforesaid purpose, and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the same; and

WHEREAS, by the award letter dated August 23, 2019, the State of New Jersey, Office of the Attorney General, Department of Law and Public Safety has awarded the City of Newark the New Jersey Victim Assistance Grant (Central Ward Project) in the amount of Four Hundred Thousand Dollars and Zero Cents (\$400,000.00). The aforementioned program focuses on support and empowerment to individuals and families who have been impacted by violent crimes and will initiate helping victims to restore dignity and safety within the City of Newark and surrounding area(s); and

WHEREAS, the City's Department of Health and Community Wellness will be submitting, contemporaneously, a companion Apply and Accept Resolution for Municipal Council approval; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriations adopted in 2020 pursuant to <u>N.J.S.A.</u> 40A:4-20, including this resolution, total \$......\$210,456,644.24

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:
