WHEREAS, Ordinance 6PDF-e, adopted on May 20, 2015, authorizes the designation of an intersection, etc. for honorary and ceremonial purposes; and

WHEREAS, Mrs. Mary V. Ambrose, affectionately known as "Doll Doll" was a longtime Newark resident and proud mother of Anthony Ambrose III, the City of Newark's Chief Law Enforcement Officer and current Director of the Department of Public Safety.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Municipal Council hereby authorizes the honorary and ceremonial renaming of the intersection of North 4th Street and Abington Avenue as "Mary V. Ambrose Way".

2. The official name of the said streets shall remain North 4th Street and Abington Avenue in their entirety.
