**WHEREAS**, the appalling arrests and murder of Mr. George Floyd by members of the Minneapolis Police Department sparked weeks of public outrage, demonstrations and civil disobedience, in cities throughout the United States and abroad; and

**WHEREAS**, in the aftermath of the protests and demonstrations, there has been a public outcry and demand for the rehabilitation and reform of police practices, operations, and funding; and

**WHEREAS**, the African Diaspora for Justice Organization, a subsidiary of Africa 400 Years.Org, has planned a peaceful protest in the City of Newark to provide its membership and the residents of Newark the opportunity to express their support and solidarity with fellow citizens affected by police brutality and the maltreatment of people of color; and
