**WHEREAS**, an emergency has arisen in the Special Item of Appropriation in the amount of Four Hundred Ninety-Eight Thousand, Nine Hundred Sixty Dollars and Zero Cents (\$498,960.00) for FY 2020 Summer Youth Employment Program (SYEP) and no adequate provision has been made in the 2020 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

**WHEREAS**, by an award letter dated June 1, 2020 from the New Jersey Department of Labor and Workforce Development, the City of Newark was awarded funding for FY 2020 SYEP in the amount of Four Hundred Ninety-Eight Thousand, Nine Hundred Sixty Dollars and Zero Cents (\$498,960.00) to provide funds for program operations; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, the emergency appropriations adopted in 2020 pursuant to <u>N.J.S.A</u>. 40A:4-20 including this resolution total \$379,883,013.78.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. An emergency appropriation be and the same is hereby made for the following classification:
