**WHEREAS,** Ordinance 6PDF-e, adopted on May 20, 2015, authorizes the designation of an intersection, for honorary and ceremonial purposes; and

**WHEREAS,** Regena McCray Palmer was born and raised in Newark and worked for the City of Newark in the Department of Administration, Office of Management and Budget for eighteen (18) years; and

**WHEREAS,** Regena McCray Palmer was a prominent Newark resident and community activist; and

**WHEREAS,** Regena McCray Palmer participated in many Newark organizations, both civic and religious over the years, including receiving her Clergy Ordination Certificate and License in 2008; and

WHEREAS, she tirelessly served the public by monitoring at-risk youth in juvenile detention centers; served as a Chaplain with the Clergy Affairs Unit of the Department of Public Safety, Division of Police; lent her expertise to the Newark Renaissance House and the Clinton Hill Preservation Committee, and generously gave her time for various food banks for Sanctuary Church; among other activities; and

WHEREAS, the Municipal Council wishes to name an intersection in her honor.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Municipal Council hereby authorizes the honorary and ceremonial renaming of the intersection of Rose Terrace and Treacy Avenue as "Regena McCray Palmer Plaza".
- 2. The official name of the said streets shall remain Rose Terrace and Treacy Avenue.
