# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designees, the Qualified Purchasing Agent the Business Administrator and/or the Director of the Department of Public Safety, Division of Fire are hereby authorized to accept, at no cost to the City of Newark, the donation/gift of 100,000 PPE surgical masks from Firefighters League of Activities Mentoring and Education (F.L.A.M.E) via Bristol-Myers Squibb Company and the Trenton Fire Department, for the protection and safety of Newark New Jersey Fire Department and the community.
- 2. The Fire Chief is authorized to execute, on behalf of the City of Newark, a Donation Terms and Conditions Agreement presented by FLAME, for Donor Bristol-Myers Squibb Company via Trenton Fire Department.
- 3. The agreement is ratified from March 22, 2022 to the date of adoption of this authorizing resolution.
