WHEREAS, the City of Newark, Department of Engineering, Division of Traffic and Signals (the "City"), advertised for receipt of bids on June 10, 2022, for street paving for Contract #2022-02, Citywide Streets 2022; and

WHEREAS, on June 23, 2022, the City provided vendors who picked up a bid with Addendum #1; and

WHEREAS, on July 7, 2021, the City received four (4) bids for Contract #2022-02, Citywide Streets 2022 in the City of Newark; and

WHEREAS, based on a review of the bids, the Acting Director of the Department of Engineering desires to accept the bid proposal submitted by the lowest responsive and responsible bidder, JA Alexander, Inc., 130-158 JFK Drive, Bloomfield, New Jersey 07003 and enter into and execute Contract #2022-02, Citywide Streets 2022, for the total bid amount not to exceed Five Million Two Hundred Fourteen Thousand Four Hundred Sixty-Six Dollars and Fifty-Five Cents (\$5,214,466.55).

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Mayor of the City of Newark and/or his designee, the Acting Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to accept the bid proposal submitted by the lowest responsive and responsible bidder, JA Alexander, Inc., 130-158 JFK Drive, Bloomfield, New Jersey 07003, and enter into and execute Contract #2022-02, Citywide Streets 2022 for street paving in the City of Newark, for the total bid amount not to exceed Five Million Two Hundred Fourteen Thousand Four Hundred Sixty-Six Dollars and Fifty-Five Cents (\$5,214,466.55).

2. Pursuant to <u>N.J.A.C.</u> 5:30-5.5(a), a Temporary Budget, attached hereto is a partial Certification of Funds issued by the Chief Financial Officer, which states funds in the amount of Two Million Eight Hundred Eleven Thousand Two Hundred Ninety-Four Dollars and Fifty-Four Cents (\$ 2,811,294.54) are available from Business Unit 045, Dept. 21A, Div./Proj. 21A22, Account# 94710, Budget Ref. B2021, for the purpose set forth hereinabove.

3. No changes to this contract are allowed without prior Municipal Council approval.

4. A fully executed copy of the contract shall be filed in the Office of the City Clerk by the Acting Director of the Department of Engineering.

5. This contract is to be completed within a period of 365 consecutive calendar days from the date of the issuance of a formal Notice to Proceed by the Acting Director of the Department of Engineering.

6. The public bidding process under the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1, et seq., complies with the Fair and Open Process of the State of New Jersey Local Unit Pay-to-Play Law, <u>N.J.S.A.</u> 19:44A-20.5, et seq.
