WHEREAS, The New Fun Services, LLC fully understands and agrees it is not entitled to receive any direct benefit from the City of Newark in exchange for this gift; and

WHEREAS, the Director of the Department desires to accept the gift valued at Four Thousand, Four Hundred Dollars and Zero Cents (\$4,400.00) from The New Fun Services, LLC., for the purpose of providing entertainment and services for the City of Newark, pursuant to N.J.S.A. 40A:5-29; and

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:
