## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. That in accordance with the provisions of N.J.S.A 40A: 4-87, the City of Newark, New Jersey hereby requests the Director of Local Government Services to approve a budget insertion in the amount of Sixty-Five Thousand Dollars and Zero Cents (\$65,500.00) and an appropriation of an equal amount for the FY 2022 HRSA American Rescue Plan Program in the budget year 2022 as set forth in Schedule A, attached hereto and made a part hereof.
- 2. That the aforesaid insertion is, in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
- 3. A copy of this Resolution shall be filed with the Director of the Division of Local Government Services by the Acting City Clerk.

## **STATEMENT**

This Resolution is establishing an appropriation and revenue for the FY 2022 Municipal Budget in the amount of \$65,500.00 for the FY 2022 HRSA American Rescue Plan Program. The United States Department of Health and Human Services/Health Resources and Services Administration is providing these funds. The project period is April 1, 2021 through March 31, 2023 (Citywide).
