WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division Local Government Services may approve the insertion of any Special Item of Revenue in the budget of any local unit when such item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of an

appropriation item of equal amount for the purpose of carrying out the purposes of the law making such item of revenue available for expenditure; and

WHEREAS, the United States Department of Health and Human Resources Health, Health Resources and Services Administration (HRSA) has made grant funds available Two Hundred Sixty-Nine Thousand Seven Hundred Seventy-Nine Dollars and Zero Cents (\$269,779.00), for the provision of an Ending the HIV Epidemic PCHP Program; and

WHEREAS, by an award letter dated April 18, 2022, from the United States Department of Health and Human Resources Health, Health Resources and Services Administration, the City was awarded Two Hundred Sixty-Nine Thousand Seven Hundred Seventy-Nine Dollars and Zero Cents (\$269,779.00), for the provision of an Ending the HIV Epidemic PCHP Program.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. In accordance with the provisions of N.J.S.A. 40A: 4-87, the City of Newark, New Jersey hereby requests the Director of Local Government Services to approve a budget insertion in the amount of Two Hundred Sixty-Nine Thousand Seven Hundred Seventy-Nine Dollars and Zero Cents (\$269,779.00), and an appropriation of an equal amount for the FY 2022 HRSA Ending the HIV Epidemic PCHP Program in the budget year 2022 as set forth in Schedule A, attached hereto and made a part hereof.
2. That the aforesaid insertion is, in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
3. A copy of this Resolution shall be filed with the Director of the Division of Local Government Services by the Acting City Clerk.

STATEMENT

This Resolution is establishing an appropriation and revenue for the FY 2022 Municipal Budget in the amount of \$269,779.00 and an appropriation of an equal amount for the FY HRSA Ending the HIV Epidemic PCHP Program. The United States Department of Health and Human Resources Health, Health Resources and Services Administration (HRSA) is providing these funds. The project period is April 1, 2022 through December 31, 2022.
