WHEREAS, an emergency has arisen in the Special Item of Appropriation in the amount of One Hundred Thousand Dollars and Zero Cents (\$100,000.00) for New Jersey Local, Empowered, Accountable, and Determined (NJLEAD) Reentry Initiative and no provision has been made in the 2023 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

WHEREAS, by Resolution 7R2-s adopted on April 5, 2023, the City of Newark (the "City") accepted funds for NJ LEAD Reentry Initiative in the amount of One Hundred Thousand Dollars and Zero Cents (\$100,000.00) from the State of New Jersey Department of Corrections, to provide funds for re-entry services to former inmates returned to City jurisdiction and reduce recidivism via a reentry liaison position; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, the emergency appropriations adopted in 2023, pursuant to <u>N.J.S.A</u>. 40A:4-20 including this Resolution total \$316,392,859.54.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. No less than two-thirds of all members therefore affirmatively concurring, that:
