**WHEREAS,** pursuant to <u>N.J.S.A</u>. 40A:9-121, the City may appoint a Constable for a term of three (3) years, unless the Municipal Council, by its Resolution of appointment, fixes a one (1) year term; and

**WHEREAS,** the City wishes to appoint Abdias Artiles to serve as a Constable for a term of three (3) years.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Abdias Artiles, of Newark, New Jersey 07106, is hereby appointed as a Constable, in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions, lockouts, legal documents, small claims and writs of execution.
- Prior to carrying out the duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Municipal Council.
- 3. This appointment shall be for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
