AN ORDINANCE REPEALING, IN ITS ENTIRETY, ORDINANCE 6PSF-B ADOPTED ON MARCH 16, 2022, CODIFIED AS TITLE 2, ADMINISTRATION, CHAPTER 2.2, OFFICE OF THE MAYOR AND AGENCIES, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, SECTION 103, AN OFFICE OF HOMELESS SERVICES TO PROVIDE VIABLE OPTIONS FOR PERSONS AT RISK OF HOMELESSNESS

WHEREAS, the Municipal Council adopted Ordinances 6PSF-b on March 16, 2022 creating the Office of Homeless Services under the Office of the Mayor and Agencies; and

WHEREAS, the Newark Municipal Council wishes to repeal same.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY THAT:

1. Ordinance 6PSF-b adopted by the Newark Municipal Council on March 16, 2022 is hereby repealed in its entirety.
2. The repeal of this ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey.
