**WHEREAS**, an emergency has arisen in the Special Item of Appropriation in the amount of \$75,440.000 for the Targeting Violent Crime Initiative Grant Program (TVCI) and no adequate provision has been made in the 2013 Temporary Budget for the aforesaid purpose and N.J.S.A 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

**WHEREAS**, by Resolution 7R11-A adopted by the Newark Municipal Council on February 20, 2013, the City of Newark accepted the 2012-2013 Targeting Violent Crime Initiative Grant (TVCI) awarded by the New Jersey Office of the Attorney General, Department of Law and Public Safety, Division of Criminal Justice, in the amount of \$75,440.00 to fund overtime initiatives that address violent crimes in the most violent areas of the Central Ward of Newark; and

**WHEREAS,** N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** the emergency appropriations adopted in 2013 pursuant to <u>N.J.S.A.</u> 40A:4-20, including this resolution total \$14,363,160.66.
