## **Legislation Text**

**WHEREAS**, the City of Newark through its Purchasing Director wishes to utilize the State Contract T-2776, Police Vehicles: Sedans and Sport Utility Vehicles, contract to purchase products or services from an authorized vendor under the New Jersey Cooperative Purchasing Program 1-NJCP, pursuant to N.J.A.C. 5:34-7.29; and

**WHEREAS**, the purchase of goods and services by Local contracting units are authorized by Local Public Contracts Law, N.J.S.A. 40A: 11-12; and

**WHEREAS**, in accordance with N.J.S.A. 40A:11-11(5), N.J.S.A. 52:25-16.1 et seq. and N.J.A.C. 5:34 -1.7, all Cooperative Purchasing Program participants are responsible for ensuring that the Purchase Order issued reflects the correct contract item pricing and that payment is processed accordingly. Only the items/services specified in the applicable State contract(s) may be purchased from the contract vendor(s) of record. Cooperative Purchasing participants assume full responsibility for all purchase transactions issued through State contracts, including Purchase Orders, delivery compliance, and payments; and

**WHEREAS,** the City wishes to utilize the State Contract T-2776 with the following vendor commencing adoption of this resolution to October 24, 2014, inclusive of any subsequent extensions to the term of the contract.

WHEREAS, the Purchasing Director recommends the utilization of this state contract award on the grounds that it provides Police Vehicles: Sedans and Sport Utility Vehicles, according to

specifications required by the City of Newark; and

**WHEREAS**, the total cost for the purchase of Police Vehicles: Sedans and Sport Utility Vehicles, is expected not to exceed \$241,550.00; and

WHEREAS, use of this contract provides police vehicles required by the Police Department; and

**WHEREAS**, the Chief Financial Officer has certified the availability of funds.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Pursuant to N.J.S.A. 40A:11-1 *et seq.*, and N.J.A.C. 5:34-7.29, the Purchasing Director is authorized to utilize State Contract T-2776 with vendor contract # A82925, Chas. S. Winner Inc., d/b/a Winner Ford, 250 Berlin Road, Cherry Hill, New Jersey 08034, to provide **POLICE VEHICLES**: **SEDANS AND SPORT UTILITY VEHICLES**, for the period commencing from the adoption of this resolution to October 24, 2014, inclusive of any subsequent extensions to the term of this state contract.
- 2. There shall be no amendment of this resolution without the approval of the Municipal Council.
- 3. There shall be no advance payment on this State Contract in accordance with N.J.S.A. 40A: 5-16.
