**WHEREAS**, the Acting Chief Financial Officer certifies that there are sufficient appropriated funds for the purpose stated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Pursuant to N.J.S.A. 40A:11-1 *et seq.*, and N.J.A.C. 5:34-7.29, the Purchasing Director is authorized to utilize State term contract T-2007, vendor contract # A83013, Celebrity Ford d/b/a Beyer Ford, 170 Ridgedale Avenue, Morristown, New Jersey 07962 to provide **VEHICLES, SPORT UTILITY (SUV)**, for the period commencing from the adoption of this resolution to complete delivery, not to exceed October 29, 2014.
- 2. There shall be no amendment of this resolution without the approval of the Municipal Council.
- 3. There shall be no advance payment on this State contract in accordance with N.J.S.A. 40A: 5-16.
- 4. Funds for the purchase of this vehicle are encumbered on purchase order #99613, NW011, Acct. #30150, Budget B2014 for \$24,708.00. This contract shall not exceed \$24,708.00.
- 5. This contract complies with Local Pay- to- Play, N.J.S.A. 19:44A-20.5 as a state contract award and constitutes a fair and open procedure.
- 6. The Purchasing Director shall forthwith file a duly executed copy of the contract in the Office of the City Clerk.
- 7. If required by State Law, the City Clerk shall provide the appropriate notice of the award of this contract to the State Comptroller no later than 20 business days following such award, in accordance with N.J.S.A. 52:15C-10 and the Notice of the Office of the State Comptroller dated May 7, 2008.
