WHEREAS, N.J.S.A. 40A:11-4.1(i), specifically authorizes municipalities to use competitive contracting for any goods or services that is exempt from bidding pursuant to N.J.S.A. 40A:11-5; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4-3 (a), in order to initiate competitive contracting, the Municipal Council must pass a resolution authorizing the use of competitive contracting each time specialized goods or services are desired to be contracted; and

WHEREAS, the competitive contracting process shall be administered by the Director of the Department of Health and Community Wellness pursuant to N.J.S.A. 40A:11-4.3 (b) and any contract awarded under this process shall be made by resolution of the Municipal Council, subject to the provision of Subsection e of N.J.S.A. 40A:11-4.5.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY THAT:

- 1. The Municipal Council hereby authorizes the use of competitive contracting pursuant to N.J.S.A 40A:11-4.1 *et seq.*, to procure goods or services related to emergency preparedness for the Metropolitan Medical Response System program.
- 2. The award of such a contract (s) shall be by resolution and approval of the Municipal Council.
- 3. The competitive contracting process shall be administered by the Director of the Department of Health and Community Wellness and/or designee, pursuant to N.J.S.A. 40A:11-4.3(b) and any contract awarded under this process shall be made by resolution of the Municipal Council, subject to the provisions of N.J.S.A. 40A:11-4.5.
