**WHEREAS**, a suit was instituted in the Superior Court of New Jersey, Law Division, Essex County, captioned <u>John Jewell, Jr. v. City of Newark</u>, Superior Court of New Jersey, Docket Number: ESX-L-5058-10, in which the plaintiff sought recovery for personal injuries; and

**WHEREAS**, it has been determined that plaintiff was injured and a proposal has been made to resolve this litigation by payment in the total amount of \$25,000.00 (Twenty-Five Thousand Dollars); and

**WHEREAS**, the Corporation Counsel based upon all facts and circumstances deems it in the best interest of the City of Newark to resolve said matter by payment of the proposed Settlement.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Corporation Counsel is hereby authorized on behalf of the City of Newark to execute and accept the terms of the Settlement Agreement and Release, attached hereto.
- 2. Upon receipt by the Corporation Counsel of all documents deemed necessary, the Acting Director of Finance is hereby authorized and directed to issue a check in the amount of \$25,000.00 (Twenty-Five Thousand Dollars), which payment shall be made payable to "Shelley L. Stangler, Esq." and which payment will be mailed to The Law Offices of Shelley L. Stangler, P.C., 155 Morris Avenue, Springfield, New Jersey, 07081.
- 3. Annexed hereto is the Certification of Funds issued by the Acting Director of Finance, City of Newark, which states that there are available sufficient legally-appropriated funds from Fund 025, Agency 25T, Orgn 7t25, Object 96340, in the amount of \$25,000.00 (Twenty-Five Thousand Dollars), for the purpose set forth herein.
