WHEREAS, an emergency has arisen in the Special Item of Appropriation in the amount of \$355,479.41 for the 2014 Clean Communities Program and no adequate provision has been made in the 2015 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

WHEREAS, by Resolution 7R10-b dated January 21, 2015, the City of Newark accepted the 2014 Clean Communities Program Funds in the amount of \$355,479.41 to provide funds to supplement an existing litter reduction program and removal as well as the abatement of graffiti within the municipality; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, the emergency appropriations adopted in 2015 pursuant to N.J.S.A. 40A:4-20 including this resolution total \$56,184,886.23

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. An emergency appropriation be and the same is hereby made for the following
